Carefully fill in the data requested in the form because it will be used in the broadcasts and on the diplomas. All information must be filled in capital letters and diacritics.

The donation of participation (worth EUR25) will be paid by bank transfer to the account of the Cultural Association "Sound Art" opened at "Banca Transilvania", with the IBAN: RO52 BTRL RONC RT05 2988 4501. (CIF: 42234090.) The payment order must include: "the name of the participant-donation International Festival Online Sound Resonances 2020"- 2nd Edition
3. The video will be uploaded "Public" to the YouTube platform and the link to the upload will be emailed to asociatia.arta.sonora@gmail.com (see also Video Upload Guide in *Regulations*). If a participant chose 2 works, they must be contained in the same video. During the recording the participant must specify his/her name, age and section for which they participate. We recommend special attention to sound quality. Filming should be done under special recording conditions, without disturbances, background noises, etc.

The camera should be placed in such a way that the whole body of the interpreter (and, as the case may be, the instrument) is visible. The recordings with the performances that will be selected by the expert jury from each section will be broadcasted live on the YouTube page "Sound Art" (<https://www.youtube.com/channel/UCXtfb91Ll9BhyJND3BIEdSg>)



Privacy Policy on Personal Data Processing
