Knowing the provisions of the law, regarding false statements, I declare that I

“The masterclass courses will be held under the following special hygiene rules:

1. The masterclass courses will be held individually, or in groups of up to 3 people.
2. All participants at the International Cultural Festival “Sound Art” have the obligation to implement preventive measures against COVID-19.
3. Wearing a mask is mandatory throughout the events. For effective protection, the mask should cover the nose and mouth. The organizer reserves the right to organize an observational triage, based on which to not allow access.
4. It is mandatory to thermoscan teachers and students before having access to the courses or the recitals.
5. Only teachers and their students are allowed take part in the courses.
6. Everyone should maintain a distance appropriate to hygienic laws.
7. Before entering the course, all teachers and students are required to wash their hands and disinfect themselves.
8. Each teacher will keep a record of their students.
9. During the courses, everyone will use their own instruments, such as pencils, erasers, etc. Instruments that must be used by multiple students, such as pianos, will be disinfected after each student.
10. Any unnecessary contact, such as handshakes, adjusting the position of the interpret, etc., is prohibited.
11. The teachers will ventilate and disinfect the classroom after every student.
12. In the case of students with chronic diseases, such as asthma, or who are part of a risk group, their parents will decide if they are allowed to take classes.
13. People with respiratory diseases, symptoms of cold, cough, fever or quarantined people are not allowed to take part in courses, recitals, concerts or any other events organized within the International Cultural Festival “Sound Art””.
